### Sr. V.P. General Counsel Greyhound Lines, Inc.

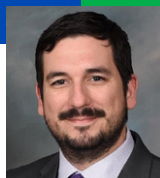

### Enterprise Specialty Claims, AVP American Family Insurance (AFICS)

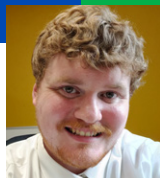
